The LTR Visa is available to four categories of foreign nationals:

- Highly Skilled Professionals
- ▶ Work-from-Thailand Professionals
- Wealthy Global Citizens
- Wealthy Pensioners

Additionally, spouses and dependents of LTR visa holders are also eligible for LTR dependent visas.

HOW TO REACH TIESC:

Private Car: Enter Entrance 3 (via Rama IV Road), park on B2-B3 (blue pole)

MRT: Lumphini Station, Exit 1 (direct to One Bangkok)

BTS: Phloen Chit Station, Exit 2, take the One Bangkok EV Shuttle **Taxi:** Enter Entrance 4 (Parade Zone Drop-off)), turn right, take elevators 3.1 or 3.2 to 6th or 7th floor (TIESC)

At One Bangkok:

Follow signs to Parade Zone, go to 5th floor, take the escalator near One Ultra Screens to reach TIESC.

LTR VISA ELIGIBILITY HIGHLY SKILLED PROFESSIONALS

2025 Criteria Update

- No work experience requirement
- Expanded to academic professors across all fields

Targeted Industries and expertise areas:

- Must work for a company in targeted industries, or
- Hold a position in targeted expertise areas

Personal Income:

- Option 1: USD 80,000/year over the past 2 years
- Option 2: USD 40,000/year over the past 2 years + Master's degree in science or technology

Targeted industries for Highly-Skilled Professional

- 1. Automotive Industry
- 2. Electronics Industry
- **3.** Affluent Tourism Industry
- **4.** Agriculture, food, and biotechnology Industry
- **5.** Transportation and logistics Industry
- **6.** Automation and robotics Industry
- **7.** Aviation, aerospace, and space Industry
- 8. Biofuels and bio-chemical industry
- 9. Petrochemical and Chemical Industry
- **10.** Digital industry
- **11.** Medical industry
- **12.** National defense industry

WORK-FROM-THAILAND PROFESSIONALS

2025 Criteria Update

- Lower revenue criteria for overseas employers to 50 million/ 3 years and inclusion of wholly owned subsidiaries
- No work experience requirement

Employer Requirements: Must work for either:

- A public company listed on a stock exchange, or
- A private company with at least 3 years of operation and combined revenue of USD 50 million in the last 3 years (a wholly owned subsidiary may use its parent company's financials)

Personal Income:

- Option 1: USD 80,000/year over the past 2 years
- Option 2: USD 40,000/year over the past 2 years + Master's degree, Intellectual Property ownership, or Series A funding of at least USD 1 million

WEALTHY GLOBAL CITIZENS

2025 Criteria Update

No personal income requirement

Investment in Thailand:

Minimum USD 500,000 in Thai government bonds (with 5+ years to maturity), direct investments in companies or Thai property

Worldwide Assets:

Personal assets, including Thai investments, totaling at least USD 1 million





WEALTHY PENSIONERS

Original criteria remain unchanged

Age: Must be over 50 years old

Passive Income:

- **Option 1:** USD 80,000/year
- Option 2: USD 40,000/year
 + a minimum of USD
 250,000 in Thai government bonds (with 5+ years to maturity), direct investments in companies or Thai property

DEPENDENTS OF LTR VISA HOLDER

2025 Criteria Update

- Expanded to include parents and legal dependents
- No limit on the number of dependents
- ▶ The legitimate spouse
- Legitimate children who are younger than 20 years old

INSURANCE REQUIREMENTS FOR ALL LTR VISA TYPES

Original criteria remain unchanged

- ▶ Health insurance coverage in Thailand of at least USD 50,000 for no less than 10 months, or
- Social Security covering full medical treatment costs in Thailand, or
- Deposit in a Thai or overseas account for a 12-month period
 - Main applicants: USD 100,000/person
 - Dependents: USD 25,000/person

VISA APPLICATION & ISSUANCE

STEP 1

ONLINE REGISTRATION

Register online and submit an application with supporting documents for LTR Visa qualification endorsement.



STEP 2 DOCUMENT VERIFICATION

Processing takes 20 working days from th date all required documents, including an additional requests, are fully submitted.

STEP 3

VISA ISSUANCE

If your qualifications are approved by the BOI, you must proceed to apply for visa issuance within 60 days of receiving the endorsement letter at:



WITHIN 60 DAYS

OPTION 1

The Immigration Bureau at TIESC: The visa fee is 50,000 Baht per person, and successful applicants will receive a visa stamp in their passport, valid up to the passport's expiry

OPTION 2

A Royal Thai Embassy/ Consulate (via the E-Visa system): The visa fee will vary depending on currency exchange rates. Successful applicants will receive an E-Visa (no physical stamp in the passport).

LTR visa holders will be granted a 5-year stay or up to the passport's expiry date upon entry, which can be extended for another 5 years.



STEP 4 COLLECTING WORK PE

COLLECTING WORK PERMITS

Request a digital work permit online. Work permits can be collected at **the Department of Employment, TIESC.** Fees apply as per the Ministry of Labor's announcement.

Note: The BOI provides free qualification endorsement processing.
