	You may need to upload your old passport upon request for further checks (To be

	Note: On the appointment date, a damaged passport may not be accepted and the applicant	
	will not be allowed to receive LTR Visa. (Signs of damage include water damage, a	
	significant tear or tears, torn out or missing visa pages, and unofficial markings). The	
	Immigration officers reserve the rights to refuse services if a damaged passport is observed.
